Payment Policy

- Registration fees, activity fees, text book, and computer lab fees are payable at time of registration. All payments can be made in cash, checks, or credit card¹. ***Textbooks are property of the school, consumables are returned to the students at the end of the school year.***
- All families are expected to make tuition payments according to one of the following payment plans.
 - Full Payment -The entire amount of tuition is paid directly to the school on or before August 1st by cash or check.
 - Monthly Payment—The entire amount of tuition is paid monthly over a ten month period beginning August 1 through the FACTS Management Company. Through this plan, the family authorizes the bank to transfer the tuition payment from a checking or savings account on the 1st of each month. An annual service fee of \$41per family will be charged by FACTS Management Company to cover the administrative costs.
- Tuition fees are for ten (10) months from August to May. Payments are to be made by the first of each month (August through May). Payments not received by the 10th of the month will be deemed delinquent.
- Fees not received by the tenth (10th) day of each month incur a late fee of \$25.00. A \$25.00 fee will apply for failed auto-debit and/or returned checks.
- The child will not be allowed to attend classes after the 20th of each month until the tuition is paid in full. Absence during this period will be considered unexcused.
- Students who withdraw after the first 30 days of school will not be entitled to any refund.
- When your child is away from school, for any reason, you will still be responsible for that period of absence and required to pay your tuition in full.
- All previously unpaid tuition must be paid by August 1st if a student is to be re-admitted the first day of class for a new school year. Payments are made directly to the school. Report cards or transfer of records will be made available only to families that have completed their financial obligations, (i.e. tuition, book, Lab fees, etc).
- GSA is a non-profit organization. We do not receive any funding from outside sources. Thus, it is essential that all payments be made in full on the date which they are due in order for us to meet our financial obligations.
